# I Admission Policy of the Department and Courses

The Master's program under the philosophy of "humanization of technology" aims to develop world-class designers who create innovative solutions to enrich our lives, and at the same time, acquire leadership skills to empower them to succeed in the future. The Graduate School of Design is looking for applicants who have the following qualities:

- Have knowledge encompassing the humanities, society, and nature; the ability to think logically; and have artistic sensitivity in order to acquire a high level of specialized knowledge related to design, to discover and raise social issues, and to acquire the ability to achieve resolutions and put them into practice.
- Have curiosity and consideration for diversity and an international viewpoint, as well as tolerance and the flexibility necessary to acquire the ability to solve problems from a broad perspective, while cooperating and having an interdisciplinary approach with people who have different expertise, values and cultures.
- Have the ability to analyze oneself and society, flexible thinking and responsiveness, creative ambition, and the ability to take action necessary to effectively utilize one's own strengths, experience, and specialized knowledge to develop and lead in new design fields.
- In addition to the above, the following students are sought for each course.

## ■ Strategic Design Course

- Have an interest in the long-term visions of society and culture.
- Have the ability to think creatively based on an understanding of people and the environment.
- Have empathy for diverse stakeholders and a desire to promote co-create value.
- Have an interest in collaborating with individuals who can implement value proposals in society.
- Have communication skills that enable one to be active on a global scale.

## ■ Environmental Design Course

- Have a strong desire to make one's own judgments about how to propose solutions to diversifying environmental issues, taking into account the vast size and historical aspects of spaces.
- Have the sufficient specialized knowledge and academic abilities necessary to acquire advanced expertise in architecture, urban design, regional design, and landscape design,
- Have the ability to observe the environment and objects in a specialized manner and creative sensitivity necessary to acquire the ability to closely analyze and understand the environment, social research skills, scientific thinking skills, expressive skills, and analytical skills.

## ■ Human Life Design and Science Course

- Have an interest in human beings in terms of how they live and have a foundation for elucidating their physiological, structural, behavioral, and psychological characteristics.
- Have an interest in human sensitivity (*kansei*) and creativity, and an interest in the visualization of the processes of these senses and design applications.

- Have scientific and engineering knowledge to make people's lives safe, secure, and appealing.
- Have a desire to solve various social problems and create value based on the characteristics of human beings in terms of how they live their lives and the latest science and technology.

#### ■ Design Futures Course

- Have a desire to live a fulfilling life together with other people, animals and plants, past and future generations that have previously been difficult to examine.
- In order to create devices, works, systems, technologies, and ways of thinking for the field of Design Futures, students should have the desire to open up new design possibilities by explaining their own pursuits to others in an understandable manner and by communicating effectively with knowledge and skills in other fields, while building on the basic abilities they developed individually in their undergraduate courses.
- For the field of Design Futures, students should have essential knowledge in one of the following areas from the specialized areas: Mathematics, Biology and Computer Science, Art and Design Theory, or Culture and Environment, and possess the ability to be analytical, creative, and communicative.

#### ■ Media Design Course

- People who conduct research and creative practice of design and artistic expression related to media and communication. Advanced creators with an aesthetic sensibility backed by logical thinking skills, and people who are oriented toward researching art and culture.
- Have advanced expressive abilities in design and content creation related to media and communication.
- Have the abilities to conduct media technology research and create contents, which are based on cutting-edge media design.
- Have knowledge of design related to media and communication, knowledge of mathematical science, and the ability to conduct advanced research on human psychology.

#### ■ Acoustic Design Course

- Understand the phenomena and principles of the fundamentals of acoustics, and have the ability to explain the phenomena and presentations from the perspectives of natural science and humanities using acoustics theory.
- Have acoustic sensitivity necessary for a specialist in acoustic design, as well as specialized knowledge in representative fields related to acoustics such as acoustic culture, acoustic environment engineering, and acoustic information science.
- Have the ability to integrate and apply the above to solve various problems related to acoustic design.
- Have the ability to open up new fields of art, science and engineering related to acoustics through multifaceted approaches to design targets from perspectives of acoustics-related culture, environment, and information.

## II Application Qualifications

### 1 April 2022 Admission (Admission by Personal Merits/ General Entrance Examination)

- (1) Applicants who have graduated from universities or colleges set forth in Article 83 of the School Education Act or are expected to graduate from such universities or colleges by March 31, 2022.
- (2) Applicants who have bachelor's degrees awarded pursuant to the regulations of section 7, Article 104 of the School Education Act or are expected to be awarded bachelor's degrees by March 31, 2022.
- (3) Applicants who have completed 16 years of formal education in their home countries or are expected to complete their education by March 31, 2022.
- (4) Applicants who have completed 16 years of formal education in foreign countries by taking correspondence courses offered in Japan or are expected to complete the aforementioned by March 31, 2022.
- (5) Applicants who have completed formal education at foreign educational institutions in Japan which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities (those who completed the education must be regarded to have completed 16 years of formal education in those countries) and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology or are expected to complete the education by March 31, 2022.
- (6) Applicants who have been awarded or are expected to be awarded by March 31, 2022 degrees equivalent to bachelor's degrees by completing the courses with the period for completion of three years or more at foreign universities or foreign schools (assessed by the foreign governments or accreditation organizations of such countries or specified as equivalent to such educational institutions by the Minister of Education, Culture, Sports, Science and Technology. (The completion of the courses includes completion of the courses in Japan through correspondence courses provided by foreign educational institutions and completion of formal education at foreign educational institutions in Japan which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology as prescribed in the preceding item.)
- (7) Applicants who have completed specialist courses of colleges of technology (only those courses which satisfy all the requirements set by the Minister of Education, Culture, Sports, Science and Technology including the period for completion being four years or more) after the date designated by the Minister of Education, Culture, Sports, Science and Technology or are expected to complete such courses by March 31, 2022.
- (8) Applicants who are designated by the Minister of Education, Culture, Sports, Science and Technology (under the Public Notice of the Ministry of Education No. 5 of 1953).
- (9) Applicants who were admitted to graduate schools under section 2, Article 102 of the School Education Act and are recognized by the Graduate School of Design to have appropriate

academic abilities for receiving education provided in the graduate school.

- (10) Applicants who are recognized to have academic abilities equivalent to those who graduated from universities by means of a qualification screening conducted by the Graduate School of Design and are at least 22 years of age as of April 1, 2022.
- (11) Students who fall under any of the following and are recognized as having earned the credits specified by the Graduate School of Design with excellent grades.
  - a. Applicants who have been enrolled for at least three years at the universities or colleges set forth in Article 83 of the School Education Act by March 31, 2022.
  - b. Applicants who have completed 15 years of formal education in foreign countries.
  - c. Applicants who have completed 15 years of formal education in foreign countries by taking correspondence courses offered in Japan.
  - d. Applicants who have completed formal education at foreign educational institutions in Japan which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities (those who completed the education must be regarded to have completed 15 years of formal education in those countries) and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology.

## **2 October 2022 Admission (Admission by General Entrance Examination)**

- (1) Applicants who have graduated from universities or colleges set forth in Article 83 of the School Education Act or are expected to graduate from such universities or colleges by September 30, 2022.
- (2) Applicants who have bachelor's degrees awarded pursuant to the regulations of section 7, Article 104 of the School Education Act or are expected to be awarded bachelor's degrees by September 30, 2022.
- (3) Applicants who have completed 16 years of formal education in their home countries or are expected to complete their education by September 30, 2022.
- (4) Applicants who have completed 16 years of formal education in foreign countries by taking correspondence courses offered in Japan or are expected to complete the aforementioned by September 30, 2022.
- (5) Applicants who have completed formal education at foreign educational institutions in Japan which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities (those who completed the education must be regarded to have completed 16 years of formal education in those countries) and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology or are expected to complete the education by September 30, 2022.
- (6) Applicants who have been awarded or are expected to be awarded by September 30, 2022 degrees equivalent to bachelor's degrees by completing the courses with the period for completion of three years or more at foreign universities or foreign schools (assessed by the foreign governments or accreditation organizations of such countries or specified as equivalent to such educational institutions by the Minister of Education, Culture, Sports, Science and Technology). (The completion of the courses includes completion of the courses in Japan through correspondence courses provided by foreign educational institutions and completion of formal education at foreign educational institutions in Japan, which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology as prescribed in the preceding item.)
- (7) Applicants who have completed specialist courses of technical colleges (only those courses which satisfy all the requirements set by the Minister of Education, Culture, Sports, Science and Technology including the period for completion being four years or more) after the date designated by the Minister of Education, Culture, Sports, Science and Technology or are expected to complete such courses by September 30, 2022.
- (8) Applicants who are designated by the Minister of Education, Culture, Sports, Science and Technology (under the Public Notice of the Ministry of Education No. 5 of 1953).
- (9) Applicants who were admitted to graduate schools under section 2, Article 102 of the School Education Act and are recognized by the Graduate School of Design to have appropriate academic abilities for receiving education provided in the graduate school.

- (10) Applicants who are recognized to have academic abilities equivalent to those who graduated from universities by means of a qualification screening conducted by the Graduate School of Design and are at least 22 years of age as of October 1, 2022.
- (11) Students who fall under any of the following and are recognized as having earned the credits specified by the Graduate School of Design with excellent grades.
- a. Applicants who have been enrolled for at least three years at the universities or colleges set forth in Article 83 of the School Education Act by September 30, 2022.
  - b. Applicants who have completed 15 years of formal education in foreign countries.
  - c. Applicants who have completed 15 years of formal education in foreign countries by taking correspondence courses offered in Japan.
  - d. Applicants who have completed formal education at foreign educational institutions in Japan which are positioned by the school system of such foreign countries as facilities that have curricula equivalent to universities (those who completed the education must be regarded to have completed 15 years of formal education in those countries) and specified as such institutions by the Minister of Education, Culture, Sports, Science and Technology.



### III Admission by Personal Merits

#### 1 Purpose of Admission by Personal Merits

The Department of Design is seeking individuals with unique capabilities who have the basic qualities to lead the field of design in the future. For the Admission by Personal Merits, we expect applicants who have achieved results through meaningful study, research, and creative activities, in their career during their undergraduate studies and other experiences prior to their admission to the Graduate School of Design. These students are selected based on document screening, and interviews.

#### 2 Enrollment Period

April 1, 2022 (Spring Admission)

#### 4 Application Requirements

Applicants must meet all of the following requirements of (1)-(3).

- (1) Applicants must fulfill the requirements of “II Application Qualifications 1 April 2022 Admission.”
- (2) Applicants must fulfill one or more of the following requirements for the Admission by Personal Merits.
  - a. Excellent academic performance (GPA) in the bachelor’s program and achievements in the desired field.
  - b. Actively engaged in research activities, such as presentations at academic conferences in the desired field.
  - c. Actively involved in creative activities in the desired field, such as participating in exhibitions, winning awards at public exhibitions or competitions.
  - d. Working adults who have made outstanding achievements for society in the relevant field.
  - e. Have other appealing achievements, such as to be qualified as a government-funded student.
- (3) Applicants must be able to assure that they will enroll in the program if they are accepted.

## 5 Application Procedure

(1) Application period: Monday, August 16, 2021 to Thursday, August 19, 2021 (9 am to 4 pm, JST)

Applications are accepted from 9 am to 4 pm if you would like to submit your application in person. Applications submitted by mail must arrive no later than Thursday, August 19. Applications from within Japan should be sent by registered mail with “Application for Admission to the Master’s Program of Graduate School of Design” written in red on the front of the envelope. If you are applying from outside Japan, please send the application by EMS or other trackable means, and submit a copy of the mailing record or the tracking number by e-mail (refer to the (2) Mailing Address and Contact Information below). Please allow plenty of time for delivery, as it may take some time especially during the Covid-19 pandemic period. Please keep a copy of all submitted documents for your records before arrival.

Furthermore, applicants who apply in accordance to the qualifications (9)-(11) will be screened in advance, so the application period is from Monday, July 26, 2021 to Thursday, July 29, 2021 at 4 pm. If you send your application by mail, it must arrive by Thursday, July 29. Applicants will be notified of the results of the screening by Friday, August 13. Applicants who have passed the qualifications screening must follow the procedure for payment of the application fee as described on page 23, and submit proof of payment of the application fee by Thursday, August 19. The application documents will be officially accepted upon receipt of the proof of payment of the application fee.

- In principle, the interview will be conducted remotely (online) using the Internet. Presentations, question-and-answer sessions, and oral examinations will be conducted remotely and evaluated by multiple interviewers.
- Please make a presentation based on the content of your research proposal and a personal statement.
- A computer and Internet connection that can support teleconferencing are required. Please prepare them yourself. Detailed information about the format and method will be sent to the email address stated in the application form.
- Presentations, question-and-answer sessions, and oral examinations will be conducted in Japanese or English. Please select the desired language in the application form.

## 8 Notes

- Applicants should contact their academic supervisor of choice before the start of the application period to thoroughly discuss the content of their research and other relevant matters. In doing so, please ascertain which Course the prospective academic supervisor belongs to.
- After the application procedures have been completed, the submitted documents cannot be changed or returned, and the application fee cannot be refunded. However, if you do not apply after paying the application fee, or if the application documents are not accepted, the paid application fee will be refunded.
- You will be asked to show your examination slip during the interview. Please have your it ready to show before the interview.
- Please correctly fill in the “Mailing label for notification of acceptance” and “Mailing label for sending documents for entrance procedures,” as these will be used as the mailing address for the respective documents.
- Incomplete applications will not be accepted.

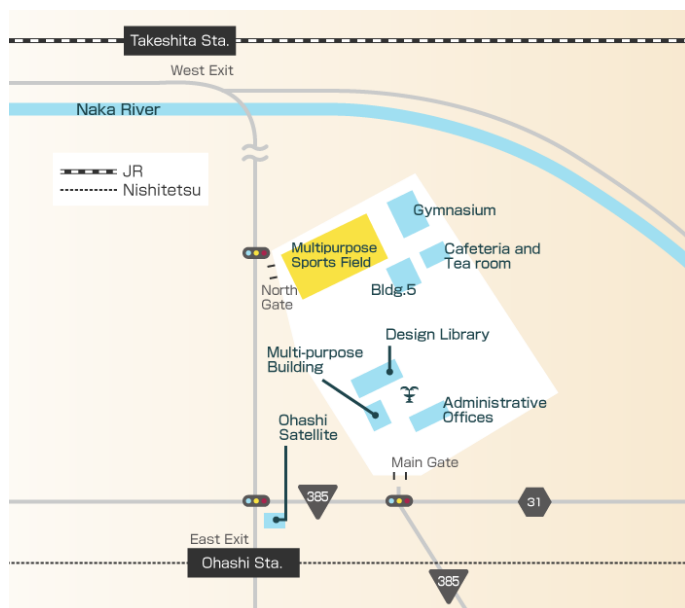

- (4) Personal information used in the entrance examination will be used anonymously as data in surveys and research on admissions selection at Kyushu University.
- (5) Personal information included in application documents and personal information, such as the results of the entrance examination, will not be used for any purpose other than the above, or provided to a third party, with the exception of the case stipulated in Article 9 of the Act on the Protection of Personal Information Held by Independent Administrative Agencies.

## **VI Enrollment**

### **1 Enrollment Procedures**

Documents related to the enrollment procedure will be sent to successful applicants in late February 2022 to those who are admitted through April 2022 Admission and in late August 2022 to those who are admitted through October 2022 Admission.

\*Note that the academic year in Japan begins in April and ends in March of the following year.

### **2 Fees Required at the Time of Enrollment**

Enrollment Fee	JPY 282,000 (subject to change)
Tuition Fee (per each semester)	JPY 267,900 (JPY 535,800 per annum, subject to change)

Note: The tuition fee may be liable to change during the period in which the student is enrolled in the Graduate School of Design. In this case, the revised amount will be applied to the tuition fee at the time of revision.

### **3 Extension of the Period of Study**

The Graduate School of Design allows students with jobs or other such circumstances who request that they complete the program according to a predetermined schedule over an extended period beyond the normal period of the curriculum to do so according to the stipulations of the Graduate School of Design.

If you are approved to extend the period of study, the amount of tuition to be paid per year will be the amount of tuition for the normal period of the curriculum (2 years) divided by the number of years (3 or 4 years) that the student is allowed to take the course as planned until the completion of the course.
